- 5) EMD : 2,000/- (Rupees Two Thousand only): EMD is required to be deposited as Bid Security and to be submitted in the form of DD/Pay Order in favour of Braithwaite & Co. Ltd payable at Kolkata. However, for SSI Units single point registration with NSIC, payment of EMD/Security Deposit can be considered for exemption to the extent of monetary limit granted on submission of valid NSIC registration certificate. Copy of the valid NSIC registration certificate should be furnished.
- 6) Credentials: Tenderer must submit the following documents as part of techno-commercial bid:
 - a) Copy of VAT Clearance Certificate
 - b) Copy of Distributorship/Dealership Certificate
- 7) Security Deposit : @ 10% of the order value only in the form of DD/Pay/ Order/Bank Guarantee from an Indian Nationalised Bank to be submitted by the successful bidder within 10 days from the date of receipt of purchase order.
- 4) Performance Bank Guarantee : After completion of the job. 10% of order value in the form of Bank Guarantee from an Indian Nationalised Bank to be submitted duly valid till completion of guarantee/warranty period. However, Security Deposit may be converted to Performance Bank Guarantee.
- 5) Payment: 100% against Proforma Invoice.. Cheque would be handed over on receipt of material at our Angus Works Stores in good conditions
- 6) Validity : Offer should remain valid for a period of 90 days from the date of opening of this tender.
- 7) Quoted rate should remain firm till completion of the job and price variation shall not be entertained.
