- F) Validity : Offer should remain valid for a period of 90 days from the date of opening of offer.
- G) Quoted rate should remain firm till completion of the supply and price variation shall not be entertained.
- H) BWT shall reserve the right to increase or decrease the ordered quantity at the same rate and terms.
- I) BWT shall reserve the right to accept or reject the tender partly or fully without assigning any reason.
- J) Liquidated Damages : In the event of failure to execute the materials within the stipulated delivery date, BWT reserves the right to recover a sum of 0.5% for every week or part thereof by way of LD subject to maximum limit of 10% of the ordered value.
- K) Risk Purchase : In the event of your failure to supply the materials BWT reserves the right to procure the items mentioned in our purchase order from alternative sources on Risk Purchase Basis and recover the extra cost thereof, if incurred, from you.
- L) Arbitration : Any dispute or difference whatsoever arising between the parties and the purchaser out of relating to the construction, meaning, scope, operation or effect of the contract or validity or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration in pursuance thereof shall be binding on the contractor.
- M) Guarantee : 12 months from the date of completion/commissioning of job. Guarantee certificate is to be provided.
