Annexure-A – Scope of Work

Supply by the party –

- i) Design, manufacture, assembly, supply, installation, testing & commissioning of one No. power pack complete with necessary components including electrical D.O.L starter suitable for the operation of one No. 500 T press (after conversion from water hydraulic to oil hydraulic system) at a working pressure of 110 bar.
- ii) Dismantling the existing water hydraulic press (500 T), renovation of cylinders, rams (4 Nos. each) (suitable for oil hydraulic system), supply of oil seals, hydraulic pipes with necessary fittings, assembly complete with pipe lines & power pack along with the existing structure, erection, testing & commissioning.
- iii) Necessary pickling & flushing chemical for cleaning of pipe line.
- iv) Complete man power, tools & tackles, gas cutting sets, welding accessories / consumables etc.
- v) Recommended hydraulic oil – Servosystem 68 of IOC or equivalent IBP Haulic 68 for initial testing & commissioning.

Note: - The power pack complete with oil reservoir and piping arrangement should be of compact design and should have the followings.

- a) Oil reservoir should have inspection door, oil level indicator, oil filter cum breather, drain valve, inside baffle plate etc.
- b) Temperature gauge (100 mm dia. – 0° to 100° C), oil level indicator, Pressure Gauge (100 mm dia. – 0 to 250 K.g/cm²)

PART-I :Techno-commercial Part : General Terms & Conditions:

- 1) EMD : Rs. 2000/- (Rupees Three Thousand only) : EMD is required to be deposited as Bid Security and to be submitted in the form of DD/Pay Order in favour of Braithwaite & Co. Ltd payable at Kolkata. However, for SSI Units with single point registration with NSIC, payment of EMD can be considered for exemption to the extent of monetary limited granted on submission of valid NSIC registration certificate. Copy of the valid NSIC Registration Certificate should be furnished.
- 2) Security Deposit : @ 10% of the order value only in the form of DD/Pay/ Order/Bank Guarantee from an Indian Nationalised Bank to be submitted by the successful bidder within 10 days from the date of receipt of purchase order.
- 3) Performance Guarantee : After completion of the job, 10% of the total order value in the form of DD/Pay Order/Bank Guarantee to be submitted duly valid till completion of guarantee/warranty period. However, security deposit may be converted to Performance Bank Guarantee.
- 4) Payment : 90% payment of the materials value against Proforma Invoice on receipt of stores and balance 10% alongwith erection & commissioning charges after successful commissioning.
- 5) Validity : Offer should remain valid for a period of 90 days from the date of opening of techno-commercial offer.
- 6) Quoted rate should remain firm till completion of the supply and price variation shall not be entertained.
- 7) Price should be quoted both in figures and words and your quotation must be free from any kind of overwriting, alteration and correction.
- 8) BWT shall reserve the right to increase or decrease the ordered quantity at the same rate and terms.
- 9) BWT shall reserve the right to split up the tendered quantity.
- 10) BWT shall reserve the right to accept or reject the tender partly or fully without assigning any reason.
- 11) Liquidated Damages : In the event of failure to supply the materials within the stipulated delivery date, BWT reserves the right to recover a sum of 0.5% for every week or part thereof by way of LD subject to maximum limit of 10% of the ordered value.
- 12) Risk Purchase : In the event of your failure to supply the materials BWT reserves the right to procure the items mentioned in our purchase order from alternative sources on Risk Purchase Basis and recover the extra cost thereof, if incurred, from you.
- 13) Arbitration : Any dispute or difference whatsoever, arising between the parties and the purchaser out of relating to the construction, meaning, scope, operation or effect of the contract or validity or the

breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration in pursuance thereof shall be binding on the contractor.
