Cost of Tender Documents : Rs. 100/- by DD/Pay Order/Cash

Earnest Money Deposit (E.M.D): Rs. 1000/- (Rupees two thousand only) E.M.D. is required to be deposited as Bid Security and to be submitted in the form of Demand Draft/Pay Order in favour of "Braithwaite & Co.
