Part-I : Techno-commercial Bid : General Terms & Conditions

Earnest Money Deposit (E.M.D): _Rs. 1000/- (Rupees One thousand only)E.M.D. is required to be deposited as Bid Security and to be submitted in the form of Demand Draft/Pay Order in favour of "Braithwaite & Co. Ltd.," payable at Kolkata which will be valid for 6 months from the date of opening of the tender. SSI Units with single point registration with NSIC, payment of EMD can be considered for exemption to the extent of monetary limit granted on submission of valid NSIC registration certificate. Copy of the valid NSIC Registration Certificate should be furnished.

Security Deposit : 10% of the order value only in the form of Bank Guarantee from an Indian Nationalised Bank to be submitted by the successful bidder within 10 (ten) days on receipt of Purchase Order.

Performance Bank Guarantee : 10% of the order value in the form of DD/Pay Order/Bank Guarantee from an Indian Nationalised Bank to be submitted after completion of the job valid till the guarantee/warranty period. However, Security Deposit may be converted to Performance Bank Guarantee.

Payment : 90% with full taxes & duties against supply through Proforma Invoice . Cheque will be handed over after receipt of all materials at BCL-Angus Works Stores in good conditions. Balance 10% would be released after successful installation & commissioning.

Delivery : Within 30 days from the date of receipt of purchase order/ 20 days after readiness of the cheque. The materials will be delivered at BCL-Angus Works, Bhadreswar, Distt: Hooghly, WB – free of cost..

Offer should remain valid for 90 days from the date of opening of this tender.

Quoted Rate shall remain firm till completion of the supply and price variation shall not be entertained.

Guarantee/Warranty : 18 months from the day of supply /12 Months from the date of commissioning, whichever is earlier.

Price should be quoted both in figures and words and your quotation must be free from any kind overwriting, alteration and corrections.

Inspection will be done by BCL Representative.

Liquidated Damages: In the event of failure to supply materials within the stipulated delivery date, BWT reserves the right to recover a sum of 0.5% for every week or part thereof by way of Liquidated Damages, subject to a maximum of 10% of the undelivered quantity.

Risk Purchase : In the event of your failure to supply the materials bcl reserves the right to procure the items mentioned in our purchase order from alternative sources on Risk Purchase basis and recover the extra cost thereof, if incurred, from you.

Arbitration : Any dispute and difference, whatsoever, arising between the parties out of or relating to the installation, meaning, scope, operation or effect of this contract or validity or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the supplier.

Jurisdiction : Any legal dispute that may arise will be settled within the jurisdiction of Court of Kolkata.
